J.Res-05-002

A Joint Resolution of the Fifth Student Congress to adopt new Student Body Constitution and Student Government Bylaws

This second joint resolution passed by the now defunct House of Representatives and the Student Senate adopted the current Student Body Constitution of Eastern Michigan University (2006) and current version of the Student Government Bylaws. The pervious constitution was discarded because of its ineffectiveness and inefficacy.

S.Res-93-001

A Resolution of the Ninety-Third Student Senate to support the Eastern Michigan University Creed

The first resolution of the Ninety-Third Student Senate was to support the Eastern Michigan University Creed. The Creed was a student-driven initiative that has since become a point of pride for the University. The Creed is read at Convocations and other University events. The Creed reads as follows:

"We believe in our ongoing **Education** through the **Integrity** of our work and **Respect** for our fellow students, faculty, and staff. We believe that the **Relationships** we have and those we continue to make will support us as we learn and grow together as a community."

A Resolution of the Ninety-Third Student Senate to support the removal of tobacco products from University owned shops

In response to student fears that some tobacco products were being used for drug-related activates, the Student Senate worked closely with University Dining Services to deal with this problem. Both sides agreed the best way to handle the situation was to remove the low-profit tobacco products from University shops.

S.Res-93-008

A Resolution of the Ninety-Third Student Senate to disassociate with the now defunct Association of Michigan Universities

The Association of Michigan Universities was, in part, begun by Eastern Michigan University (AMU) to unite the fifteen public universities of Michigan against proposed referendums that would have given universities less money to operate. Since than, AMU was used as a means for intercollegiate cooperation amongst the student government associations of the fifteen public universities. Due to the lack of a funding structure and a unanimous vote requirement on all matters, the organization became ineffective and hindered cooperation. Eastern Michigan University was the first of eight student government associations to disassociate with AMU.

Will Chapman was a great asset and resource for Student Government during his tenure. He acted as office manager and the first Judicial Sergeant. It was said that without Will, Student Government would have stopped running. Though he did not qualify for Senator Emeritus, the title of Honorary Senator was created by the Student Senate to award servant to the Student Body.
